  and federal court in tort actions, contract actions, and actions
  alleging violations of state and federal laws and statutes,
  including the Truth-in-Lending Act, Fair Debt Collection
  Practices Act, Real Estate Settlement Procedures Act, Fair Credit
  Reporting Act, Equal Credit Opportunity Act and Virginia
  Consumer Protection Act.
- Commercial Landlord Representation: Representation of commercial landlords in connection with enforcement of leases, including evictions, enforcement of landlord's liens and other collection efforts.
